Child Tax Credit	A complete copy of your TC602 Revenue & Customs tax credit award notice for the current tax year.	
Income Support	A letter from the Jobcentre plus, which uses the words 'Income Support', and is less than 3 months old.	
Income Based Job Seeker Allowance	A letter from the Jobcentre plus, which uses the words 'Job Seekers Allowance income based' and is less than 3 months old.	
Income Based Employment Support Allowance	A letter from the Jobcentre plus, which uses the words 'Employment & Support Allowance Income related only' and is less than 3 months old.	
Guaranteed element of Pension Credit	A copy of your Pension Credit M1000 Award Notice.	
Part IV of the Immigration and Asylum Act 1999	A copy of your letter from the National Asylum Support Service (NASS) which will confirm your status.
